

## **Hunting Conditions and Terms**

- 1. The first and most important rule is for all visitors to enjoy themselves on an exquisite African Bushveld Breakaway.
- 2. All hunters must have their rifles sighted in at the shooting range with the manager prior to the hunt. All firearms must be unloaded on vehicles and at the camp. Please keep your rifles locked away in the camp safe when unattended.
- 3. Animals wounded are charged at full price. The hunter's first missed shot at small game (Impala and smaller game) will cost R250, more missed shots and Importantly missed shots at large animals will account for 50% of the animal's list price.
- 4. You must satisfy yourself regarding the specie, size, health and sex of the game you want to shoot. You must not rely on the guides, as no discount is allowed for small or wrong game.
- 5. Mother with young and dependable calf visible not to be hunted.
- 6. No hunting is allowed in a 400m radius from houses and lodges.
- 7. We are not permitted for bow hunting.

8. Sundays and religious holidays e.g. Good Friday, are non-hunting days, except with prior arrangement with the Ranch.

- 9. We hunt on foot Walk & Stalk. No vehicle hunting is permitted.
- Hunter and guide must remain together at all times during a hunt. Only 1 Rifle is allowed per hunting group. <u>Guests or children are not</u> <u>permitted to walk along the hunting party.</u>
- 11. Hunting sessions: 6:00am -11:00am & 14:00pm 6:00pm.
- 12. The use of private vehicles, bikes etc. are not allowed on the ranch.
- 13. No alcohol will be allowed during any hunting session.
- 14. Please do not litter in the veld or remove or damage plants.
- 15. Smoking is prohibited in the rooms & care should be taken when smoking in the veld.
- 16. You may not give any liquor to the guides, during or after the hunt. A soft drink is more than sufficient.




17. Please do not tip the guides directly. There will be a Tip Sheet with the manager to whom tips may be

given. Management will ensure fair distribution of tips to personnel.

18. Shooting of any birds on the farm (incl. the Camp) is NOT PERMITTED. No Pellet / Air gun / slingshot or any other weapon used to hunt birds will be permitted on the farm. Birds are protected.

- 19. Calibers smaller than .243 or 6mm are not permitted, except by prior special arrangement with the ranch.
- 20. Any person making themselves guilty of misbehavior / unethical hunting / dangerous handling of firearms / abuse of alcohol will be asked to leave the farm immediately. No Refunds will be made under such circumstance.



- 21. The best stories are told next to a campfire after a good day's hunt. The fire should be kept within reasonable size and managed responsibly. Making large fires at camp is not permitted. This carries a risk to the Thatched Lapa. All damage to Volharding Game Ranch's property will be for the hunter's account. Property refers to anything which belongs to Volharding Game Ranch. Wood will be available for purchase at the Ranch, it is not permitted to collect wood from the veld.
- 22. Non-hunters must be prepared to keep themselves busy in camp during hunting sessions. The use of the swimming pool is at own risk and special care should be taken with young children around. Walking with a hunter in the veld will result in too much noise and visibility, which will affect the performance of the hunter. It can also be dangerous as a loaded hunting rifle is at hand.
- 23. The camp fees are payable in respect of all the days booked regardless of how many days utilized.
- 24. Upon making your deposit you accept and agree to all hunting conditions and terms set out herein. The full account must be settled before departure in cash or electronic fund transfer. No exceptions.
- 25. Right of admission is reserved and all persons booked shall have to **fill in & sign a personal indemnity form well before arrival**.
- 26. Hunting from a hide or "voorsit" under a tree at allocated places can be arranged under certain circumstances, always accompanied by a guide.

## **Special Notes**

- 1. It is recommended but not compulsory to use silencers on rifles. It helps to sustain the serene natural environment of the game animals.... eco-friendly.
- 2. Excellent Taxidermist details available on request.
- 3. Please note that the main farm gate will be locked after hours for your own safety, but a duplicate key will be available for emergencies
- 4. Water & Electricity should please be used wisely. Please switch off the air conditioning / lights when not in use.
- Please also take special note that we operate on a French drain septic tank system. No foreign items please.
